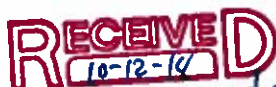

SUBJECT: October 2018 Review of Science Is Fun and Awesome Learning Academy Charter School's Invoices

Hafa Adai,

The Guam Department of Education (GDOE) Internal Audit Office (IAO) has completed its review of Science Is Fun and Awesome Learning Academy Charter School (SIFA)'s allotment request for October 2018. GDOE (IAO) is authorized by Public Law (P.L.) 34-116 to verify charter school invoices for accuracy and report its findings within 10 days.

On October 4, 2018, IAO received the Department of Administration's transmittal for SIFA's October 2018 Allotment Request of \$400,000. IAO was able to validate \$400,000 of submitted invoices.

P.L. 34-42 provides \$6,088 for each student up to 350 students or a maximum of \$2,130,800. As Based on enrollment reports provided by SIFA, 113 students were enrolled as of September 24, 2018. Based on the per pupil cast, SIFA's current FY 2019 budget is \$687,944. For FY 2019, IAO validated \$400,000 of expenditures, leaving an unexpended balance of \$287,944. See Tables 2 and 3.

Per P.L. 34-116, Guam Academy Charter Schools are to receive local appropriations in proportion to the ratio of cash received by GDOE for FY 2019. IAO will be including data relative to GDOE’s cash receipts in future validation reports as the information becomes available. Charter school available funds will be based on the proportion of cash received by GDOE as required by law.
